

## Family Mediation User Fee Schedule

The fees apply to each party for each hour of mediation and/or intake services. Notwithstanding this sliding-fee scale, parties can choose to equally share the mediation fees.

### We are committed to FEE TRANSPARENCY, so PLEASE READ BELOW:

1. In addition to mediation sessions, additional fees will be charged for producing of:

- (i) Memorandum of Understanding (3 to 5 hours)
- (ii) Draft Separation Agreement (6 to 8 hours)
- (iii) Progress Notes (1 to 3 hours)

2. In determining the fees:

(i) “each party” refers to the individuals directly involved in the mediation;

(ii) “gross yearly income” is defined to include all payments of any kind received by or on behalf of the party, the spouse and any dependent children.

(iii) “Dependants” refers to any children supported or partially supported by that party and any other person for whom the party is financially responsible. Children supported or partially supported by both parents may be counted as dependants by both parents.

(iv) The fees set out above do not include the Harmonized Sales Tax (HST). User fees are subject to HST.
